

Clwb Cerdd Dolgellau 100 Club

1. **Name** : The name of the Club ("the Club") shall be "Clwb Cerdd Dolgellau 100 Club"
2. **Aim** : The aim of the Club is to raise money to support and finance the activities of Clwb Cerdd Dolgellau
3. **Promoters** : The Club will be administered by promoters appointed from time to time by the Committee of Clwb Cerdd Dolgellau ("the Committee") and their names shall be available to Members on request
4. **Member** : A Member shall be a person or persons who has purchased a Subscription. Members must be 16 years of age or above.
5. **Subscription** : The Subscription or membership of the Club shall be £12.00 per annum payable by cheque or by standing order. In return for such payment the Member shall be given a ticket ("the Ticket") with a unique number. Members may purchase more than one Ticket. A Ticket entitles the Member to a chance to win a prize in each of the 8 draws during the 12 month period from the start of the subscription to its anniversary. Numbers / members which are not paid up will not be entered in the draw.
6. **Payment** : One half of the total Subscriptions received by the Club in any year shall be distributed to members as prize money in the following percentages:
 - a. 30% First Prize
 - b. 20% Second Prize

The remaining half of the total Subscriptions received in any year will be retained by the Club and used to finance/support Clwb Cerdd Dolgellau in whatever manner the Committee deem appropriate. Prizes may be adjusted according to the number of members participating and at the discretion of the Committee.
7. **Date/Time of Draws** : Draws will be held at each of the seven concerts of Clwb Cerdd Dolgellau and at the Annual General Meeting. There will therefore be 8 draws held in one calendar year.
8. **Notification** : Winners who are not present at the Draw will be notified by letter within 7 days of the Draw taking place and a cheque for the amount will be issued to the winning Member within that 7 days.
9. **Winners' Details** : A list of winners will be available for inspection at Clwb Cerdd Dolgellau concerts and posted on its Web Site. A Statement of Account shall be presented with the Annual Balance Sheet of Clwb Cerdd Dolgellau at its AGM
10. **Cancellation** : Notice of cancellation in writing from any member not wishing to renew must be sent to the secretary of Clwb Cerdd Dolgellau: Mrs. Anne Anslow, Sarn, 9 Springfield Street, Dolgellau, LL40 1LY.
11. **Disputes** : disputes of whatever nature will be decided by a sub-committee of Clwb Cerdd Dolgellau (which sub-committee shall not include any of the promoters) whose decision shall be final and binding on Members.
12. The Committee shall have powers to add to, amend or remove any of the aforementioned rules, consistent with ensuring compliance with the relevant legislation
